Sir,

With reference to the correspondence resting  
with this office on the subject noted above, I am to  
convey the orders of the Director of Education, Delhi  
extending the period of provisional Recognition of  
your school w.e.f. 1.5.1977 to 30.4.1978 from class  
VI to XII subject to the following conditions:-

1. Sufficient/class rooms be built to accommodate  
all the sections shall be constructed.
2. The play grounds of the school shall be properly  
marked.
3. A fresh certificate from the concerned Health  
Officer as to the satisfactory Health and Sanitary  
conditions of the school shall be obtained and  
furnished to this office.
4. The school shall extend to its employees all the  
benefits of service, as provided under the  
Delhi School Education Act/Rules, 1973.
5. The school shall deposit an additional sum of  
Rupees 5000/- in its Reserve Fund.
6. The constitution of the Managing Committee shall  
be according to Rule 59 of the D.S.E. Rules, 1973.
7. Addition/abolition of Section/Subject in any  
class shall not be allowed without the prior  
permission of the Director of Education, Delhi.
8. The school premises shall not be utilized for  
commercial, residential, political or non-edu-  
cational activities of any kind whatsoever.



10. The service of any employee of the school shall not be terminated without prior approval of the Director of Education, Delhi.
11. The school and its Management shall observe all the concerned provisions of D.S.E. Act/Rules, 1973 and the instructions issued by the Department from time to time.
12. The school shall furnish a compliance report in respect of the fulfilment of the above conditions to the Department by 30.4.1978.






